## 2010 RULES

- All Captains/Boatmen must be registered.
- The team captain is responsible for picking up the fishing giveaways the week of August 2-6, 2010. **(No items will be given away at tournament. Late registration only.)**
- The Contest begins at 6:00A.M. On Saturday, August 21, 2010. No fishing allowed before 6:00A.M.
- Weigh-in begins at 12:00P.M. All anglers must be a registered contestant of tournament and must accompany **ONLY 1** fish per species to weigh station at Louie's Backyard. **NO LATER THAN 2:00P.M. NO EXCEPTIONS.**
- All decisions made by Weigh Master are final. Weigh Master will be Calixto Gonzalez, Salt Water Editor for Texas Fish and Game Magazine.
- Official Tournament time will be kept at tournament headquarters. Weigh-in deadline is according to official tournament time.
- All Anglers will be required to initial weigh cards. Anglers assume responsibility of meeting Texas Parks and Wild Life requirements.
- 4 Anglers max per boat (Including Captain and/or Guide)
- **Guided Division means every angler in a boat with a guide competes in the guided division and not just the guide. The guided cannot give fish that he or she catches to other anglers on the boat.**
- Tournament committee reserves the right to categorize angler division.
- All bay anglers, including juniors, are restricted to one fishing line per angler in the water at any given time.
- **NO OVERSIZE REDFISH OR TAG FISH WILL BE WEIGHED. Any angler weighing in a fish that does not meet the state requirements at the weigh station will be disqualified from the tournament.**
- All anglers must have a valid Texas Fishing License unless exempt.
- If two or more fish are tied in weight, the winner will be decided according to length (Longest wins). If there is a tie after length is measured, **FIRST FISH** weighed wins.
- Anglers must be present when their fish is being weighed-in. No fish can be weighed-in by proxy.

- All fish will be weighed in according to Texas Parks and Wildlife guidelines (mouth closed, tail pinched).
- Tournament committee has the right to issue a random polygraph test.
- The Committee reserves the right to refuse participation.
- **NO MUTILATED FISH** (this includes bloody or altered fins, missing body parts, bisected stomach cavities, and damaged facial structure).
- The Weigh Master reserves the right to refuse to weigh in any fish that he deems questionable. Any tournament official also reserves the right to disqualify any fish due to un-sportsmanlike conduct (including belligerent or confrontational anglers and fighting in line).
- The Weigh Master reserves the right to open any fish's stomach cavity to inspect the contents of the digestive tract. This will be done in the presence of a second tournament official. Any fish with non-organic matter in its digestive tract may be disqualified. If an angler refuses, the angler will be disqualified.

One Grand Champion will be awarded for each division.

A Grand Champion will be determined by the combined total weight of one Redfish, one Trout, and one Flounder by each angler.

It is not a requirement to weigh-in one of each species to be eligible for Grand Champion.
